The population of England and Wales is approximately 57m people and of these 127,909 were police officers at March 2014.



Attend 9 road traffic collisions where there were casualties and undertake 8 breath tests.

In addition to reacting to calls for service from the public, on a typical day the police will also be undertaking proactive work to safeguard the public including:



upporting 2,700 families enrolled in the **troubled** families programme.



Supporting approximate 1,600 domestic abu victims being seen Multi-Agency Ri Assessme



Managing approximately 1,189 sexual and violent offenders under Multi-Agency Public Protection Arrangement in partnership with other



Supporting 1,000 children and young people subject to a **Child Protection Plan**.



Officers will deal with - amongst other crimes - 8 dwelling burglaries, 77 thefts, 11 thefts from a motor vehicle, 3 thefts of a motor vehicle, 36 violent crimes, 1 robbery, 2 sexual assaults, including 1 rape.



They will issue 9 cautions, 3 Penalty Notices for Disorder and 3 Cannabis Warnings.

Across England and Wales, there is approximately one solice officer for every 445 members of the public, an increase of over 50 people per officer since 2010.

As well as dealing with crime, officers will:



Approximately 150 crimes are reported.

Different forces experience different levels of demand - more than 50% of all recorded crime occurs in urban, or mostly urban, forces.



- Typical demand has been estimated based on the total from the force with the median figure for each measure.

 Where estimates have been calculated per officer they are based on the number of officers in the median force.
- Using the estimate from the HMIC Policing in Austerity report that 92% of officers will be on the frontline by March 2015 – and dividing by 3 as a proxy for shifts.
- Each stop and search is estimated to take 15 minutes (a govt, estimate but no source) to complete that's 555 minutes (or 9.3hrs) per day.
- Based on estimates from 4 forces that 2% of incidents are associated with people with mental health issues.





Full time equivalent police officers in England and Wales in frontline roles, 2010-2018







Between quarter two of 2010/11 and quarter two 2016/17, the number of overnight beds fell by 14,000.


Over the same period, the number of **mental** health beds fell by a fifth.





Are all MHA detentions rising?



A recent analysis I have commissioned on section 136 demand in Kent shows that on average, between May and September 2018, Police Officers spent 5600 waiting in A&E for someone to receive treatment. That's an average of 8hours 30mins over the course of 328 incidents.

Hammond budget to give £2bn extra for mental health services

Philip Hammond will announce a £2bn increase in mental health funding today as he reveals his first budget since Theresa May told the Conservative party conference that voters needed to know austerity was over.

Bolsonaro on verge of power as Brazil votes

Afar-right, pro-gun, pro-torture populist looked poised to become Brazil's next president last night as 147 million Brazilians went to the polls at the end of a drama-filled and deeply divisive election that is likely to reforge the future of the world's fourth-biggest democracy.

Jair Bolsonaro, a 63-year-old former paratrooper who built his campaign around pledges to crush corruption, crime and a supposed communist threat, enjoyed an 8-10 percentage point lead, according to polls released on the eve of the vote.

"[Our expectation] is victory." Bolsonaro, 63, told reporters after arriving to vote near his oceanfront home in west Rio surrounded by rifle-toting police and wearing a bullet-proof vest that has become part of his wardrobe since an attempt on his life last month.

Bolsonaro's rival, the Workers' party candidate, Fernando Haddad, has gained ground in recent days and talked up the possibility of a shock reversal, although most analysts still considered that unlikely

"Ibelieve Brazil has woken up in the last few days... and I feel very hopeful about the result," Haddad, 55, said as he voted in São

Synagogue gunman 'raged about genocide'

The suspect in the mass shooting at a Pittsburgh synagogue railed about killing Iews and genocide during the 20-minute rampage, it emerged yesterday, as the 11 victims, who ranged from 54 to 97-years-old, were named.

Those who died at the Tree of Life synagogue on Saturday included a

married couple and two brothers.
The gun attack during a Shabbat service was the deadliest assault on Jews in US history, according to the Anti-Defamation League, which monitors antisemitism. Bill Peduto, the city's mayor, called it he "darkest day of Pittsburgh's history".

- Evaluation based on data/ interviews with police officers and other staff






